The preferred option from Pdf at this moment is expanding towards the north-side of Noord IV.

- Spatial preconditions Pdf (water retention, water supply, electricity, nature, etc.). For the theme park as a (also for plants) but also for water retention an artificial lake is a wish from 5.1.2e 5.1.2e (Water Management Board) states that both water retention and water quality are of main importance for them. First point is to know the amounts of hectoliters that are needed, Pdf will already work on that.
